Update on food parcels for vulnerable people



The first free food boxes containing essential supplies have been delivered in England to those at highest risk from coronavirus. More parcels are expected to go out next week from wholesalers across the country, bringing the first set of deliveries to more than 50,000.

The government plans that the number of deliveries will increase to 150,000 the following week and then 250,000, then 350,000 - to a max of 450,000 per week. These deliveries will be direct to

the clinically vulnerable who have received a letter from the NHS and requested immediate support.

The Borough council are also working with Nottinghamshire County Council to identify those residents who need support but who are not classed as clinically vulnerable. Rushcliffe Borough Council have a database of residents who will receive a letter in the next few days.

They will be asked to contact the Nottinghamshire County Council helpline if they do not have local support in place and will then be triaged back to districts for support. The Borough council should then be in a position to co-ordinate redeployed staff alongside local parishes and volunteer groups to distribute other essential items that will be provided via the Nottinghamshire County Council Community Support and Volunteering Hub.

A reminder that volunteer groups can get involved by registering on <u>the County</u> <u>Council website</u>.

All the activity is being initially co-ordinated via County Council centrally, as they have the use of military planners to assist with the co-ordination efforts.

Initial £150 council tax reduction for residents on low incomes



Central government has allocated an initial £150 reduction on annual council tax bills for low-income residents in the Borough as part of its response to COVID-19.

Over 1,800 tax payers will now receive the reduction on their bills for the 2020/21 financial year, announced as part of £500m of new hardship grant funding nationwide.

The awards will be made as soon as possible and all eligible claimants will

receive a confirmation letter. Residents should not call the Borough Council for further information, but email <u>revenues@rushcliffe.gov.uk</u>

The government outlined in its Budget on March 11 that it would provide local authorities in England with the fund which has seen us allocated £515,389.

This will now further support working-age residents who currently receive help from our Council Tax reduction scheme.

The Borough council will be initially awarding a maximum of £150 per household, who are in receipt of Council Tax Reduction from 1 April 2020, towards their Council Tax bill.

"Over 1,800 tax payers should benefit from this and the Borough are actively looking at further council tax support measures that aim to help individuals who are particularly suffering with financial hardship at this difficult time.

"There is no requirement currently for a separate claim under this scheme. The Borough will assess who is eligible for support from the hardship fund and automatically credit their accounts.

"The awards will be made this week and all eligible claimants will receive a confirmation letter."

"It may be that there are protective items sitting in storage cupboards that can be put to good use to support our social care workers, care workers and other front-line employees.

High blood pressure medication



The Medicines and Healthcare products Regulatory Agency has advised that if anyone is taking angiotensin converting enzyme inhibitors (ACE inhibitors or ACE-i) or angiotensin receptor blockers (ARBs) to treat high blood pressure, it is vitally important they continue their usual treatment.

There is no evidence from clinical or epidemiological studies that these might worsen coronavirus infection.

Telecommunication providers commit to support vulnerable consumers



The UK's major telecommunication providers have agreed to a set of commitments to support and protect vulnerable consumers and those who may become vulnerable due to circumstances arising from coronavirus.

The providers agreed:

• That they will remove all data allowance caps on all current fixed broadband services.

- To offer some new, generous mobile and landline packages to ensure people are connected and the most vulnerable continue to be supported.
- To work with customers who find it difficult to pay their bill as a result of coronavirus to ensure that they are treated fairly and appropriately supported.
- To ensure that vulnerable customers or those self-isolating receive alternative methods of communication wherever possible if priority repairs to fixed broadband and landlines cannot be carried out.

The free service is an automated 'chatbot' that will provide information on coronavirus prevention and symptoms, the latest number of cases in the UK, advice on staying at home, travel advice and myth busting.

It aims to further reduce the burden on NHS services, including 111, combat the spread of the virus and ensure people stay at home and save lives.

Watch out for coronavirus scams



Criminals are exploiting fears about COVID-19 to prey on members of the public, particularly older and vulnerable people who are isolated from family and friends.

National Trading Standards is warning people to remain vigilant following a rise in coronavirus-related scams that seek to benefit from the public's concern and uncertainty over COVID-19.

Members of the public should ignore

scam products such as supplements and anti-virus kits that falsely claim to cure or prevent COVID-19.

In some cases individuals may be pressurised on their own doorsteps to buy anti-virus kits or persuaded into purchasing products that are advertised on their social media feeds. In addition, some call centres that previously targeted UK consumers with dubious health products are now offering supplements that supposedly prevent COVID-19.

Communities are also being urged to look out for signs of neighbours being targeted by doorstep criminals. While there are genuine groups of volunteers providing help during self-isolation, there have been reports of criminals preying on residents – often older people or people living with long-term health conditions – by cold-calling at their homes and offering to go to the shops for them.

The criminals often claim to represent charities to help them appear legitimate before taking the victim's money. There are genuine charities providing support, so consumers should be vigilant and ask for ID from anyone claiming to represent a charity.

More central government support for mental health



In recognition of the unprecedented challenges which the outbreak and extended periods of self-isolation can pose, Public Health England has published <u>new online guidance</u> setting out principles to follow to help people to manage their mental health during this difficult time.

Parents and carers will also benefit from tailored advice on how to support children and young people with stress during the coronavirus outbreak, which includes providing

clear information, being aware of their own reactions and creating a new routine.

The government has also announced a £5 million grant for leading mental health charities, administered by Mind, to fund additional services for people struggling with their mental wellbeing during this time.

Reminder on Police and enforcement powers





A reminder that the government has strengthened police enforcement powers in England to

If members of the public do not comply the police may:

- Instruct them to go home, leave an area or disperse
- ensure parents are taking necessary steps to stop their children breaking these rules
- issue a fixed penalty notice of £60, which will be lowered to £30 if paid within 14 davs
- issue a fixed penalty notice of £120 for second time offenders, doubling on each further repeat offence

Individuals who do not pay a fixed penalty notice under the regulations could be taken to court, with magistrates able to impose unlimited fines.

If an individual continues to refuse to comply, they will be acting unlawfully, and the police may arrest them where deemed proportionate and necessary. However, in the first instance the police will always apply their common sense and discretion
